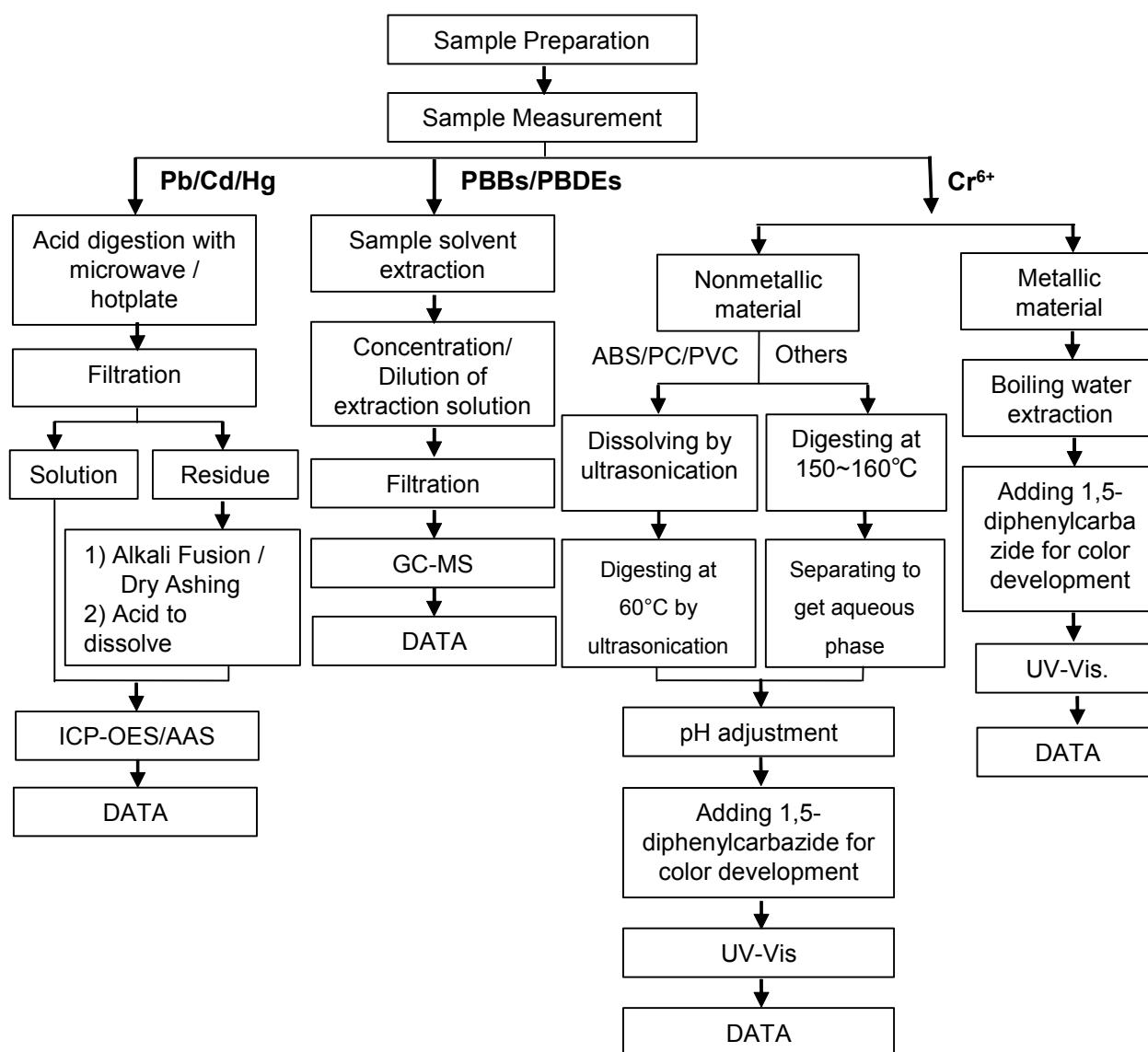

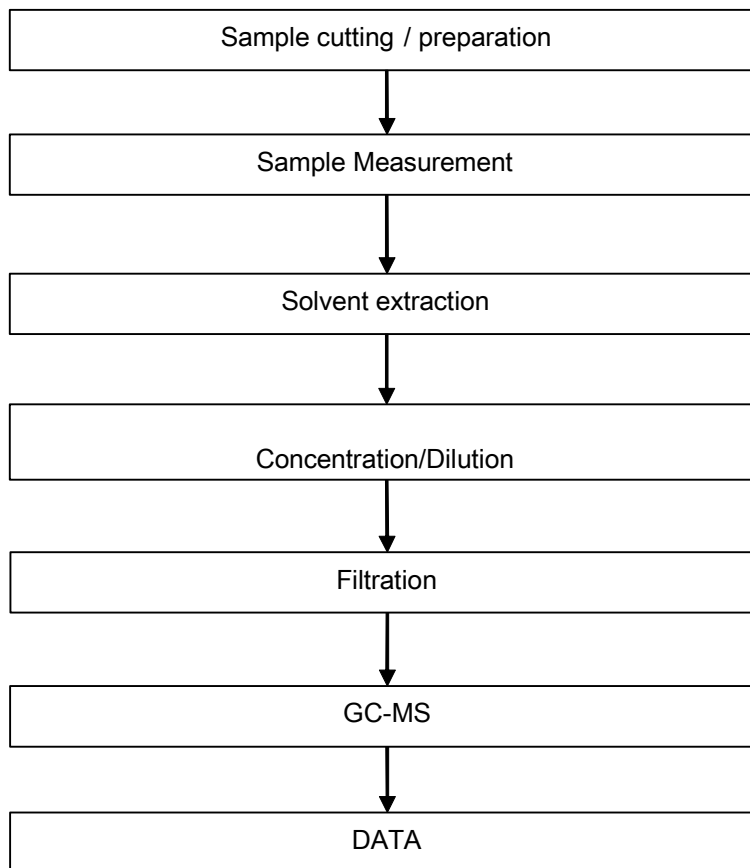

### Phthalates Testing Flow Chart



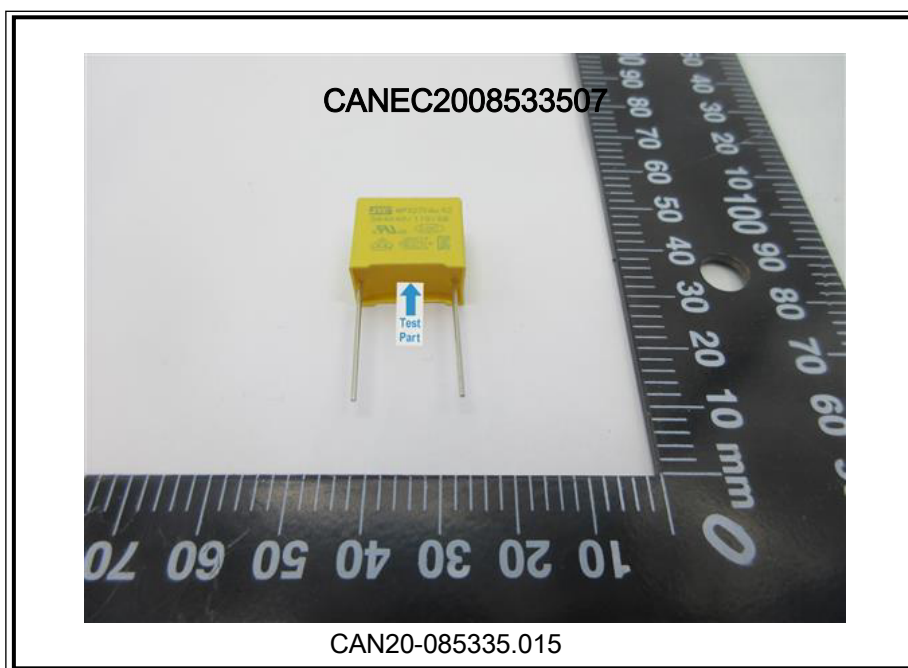
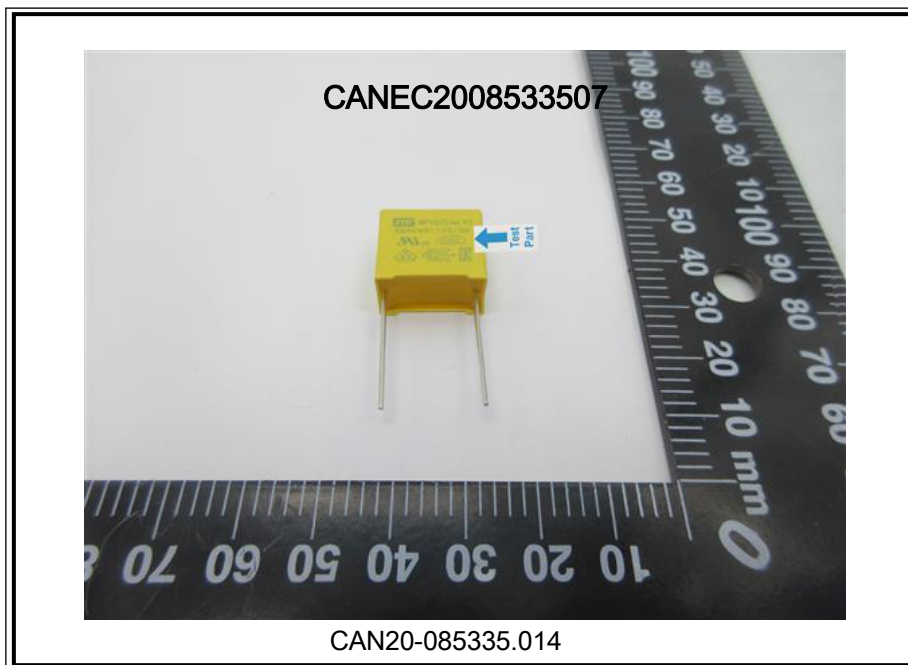
